

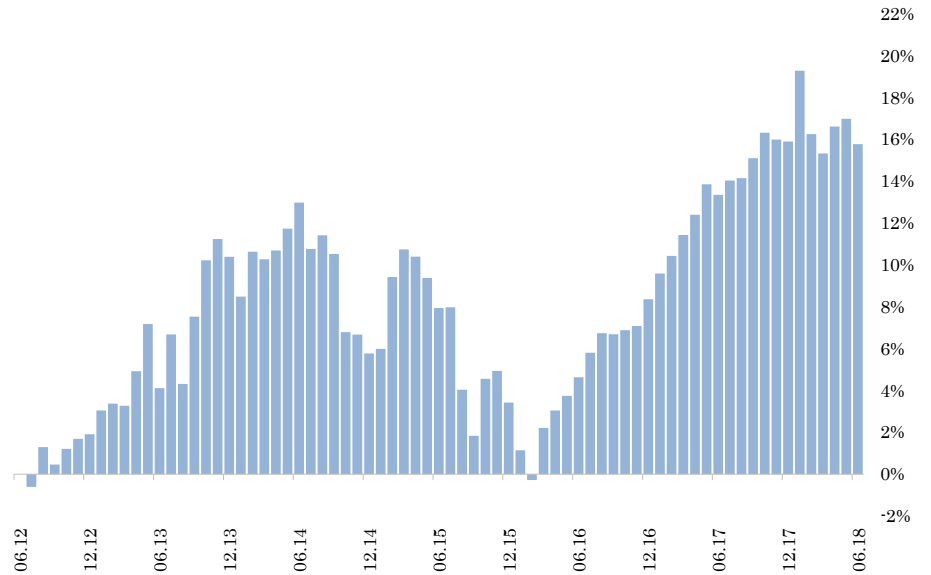
**Investment philosophy**

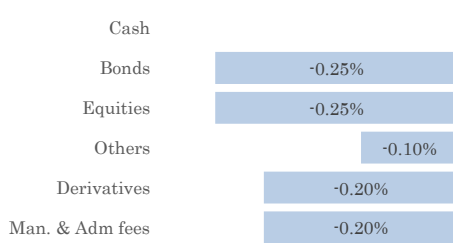

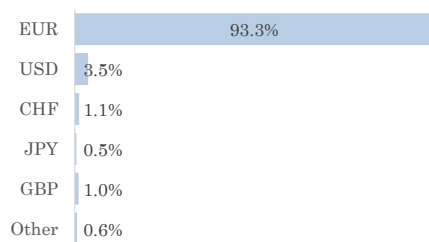
**Cumulative net return**



**Monthly contribution**



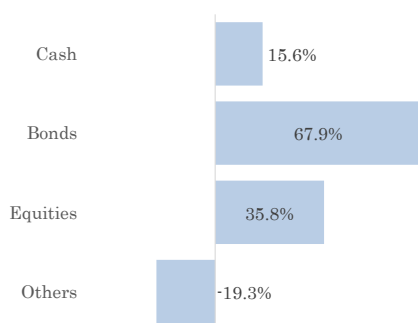

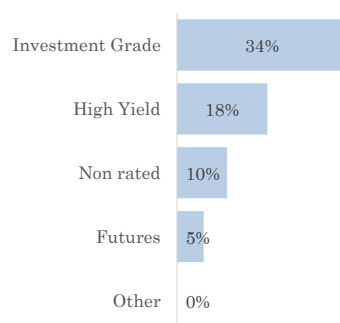

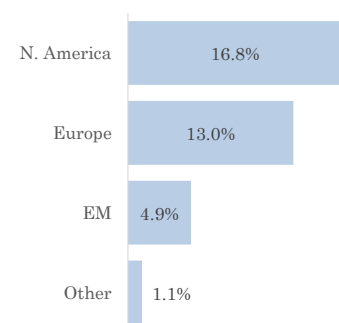
**Asset allocation**
