

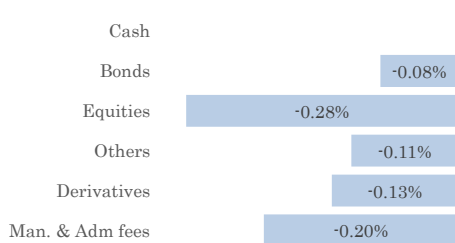
Investment philosophy

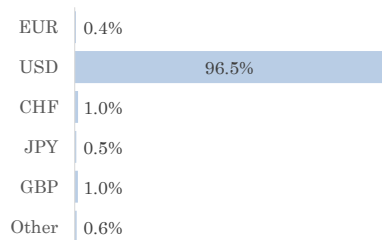

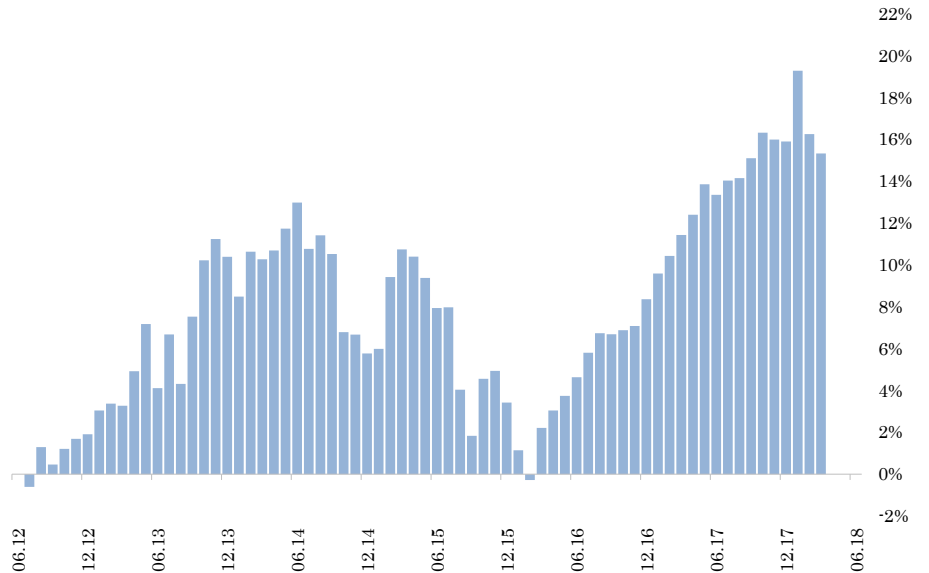
Monthly contribution



Currency allocation



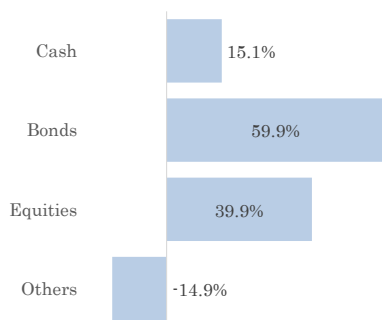
Cumulative net return



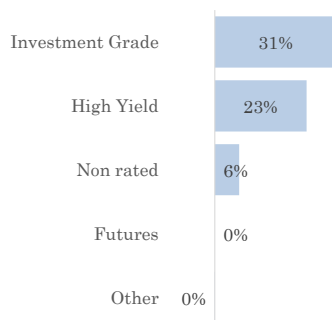

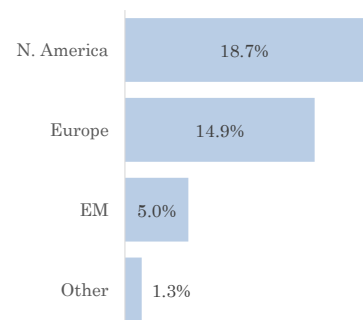
Asset allocation
