

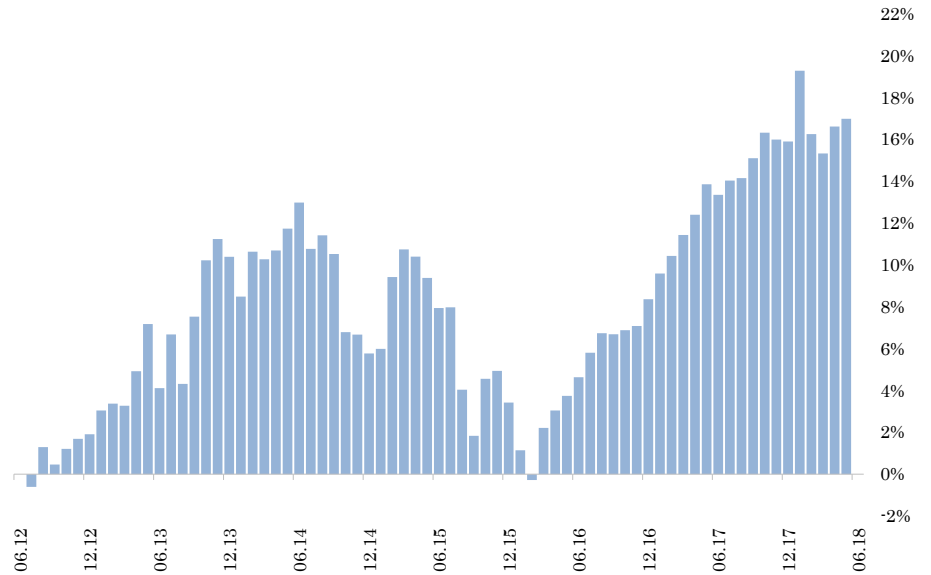
Investment philosophy

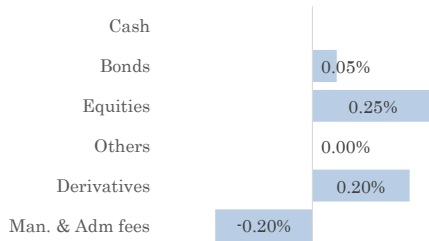

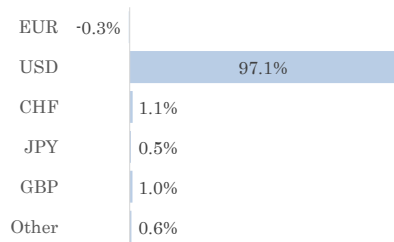
Cumulative net return



Monthly contribution



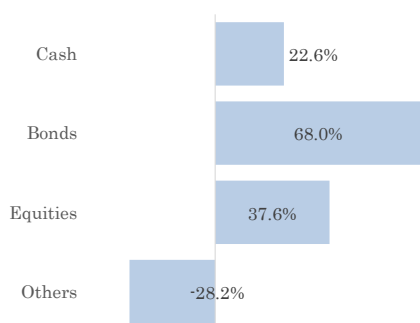

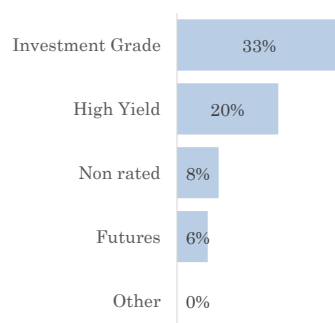

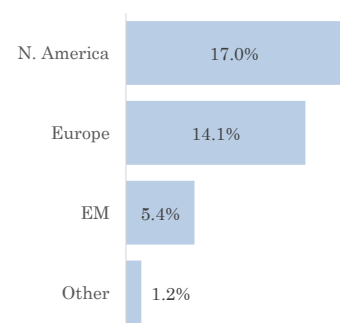
Asset allocation
