

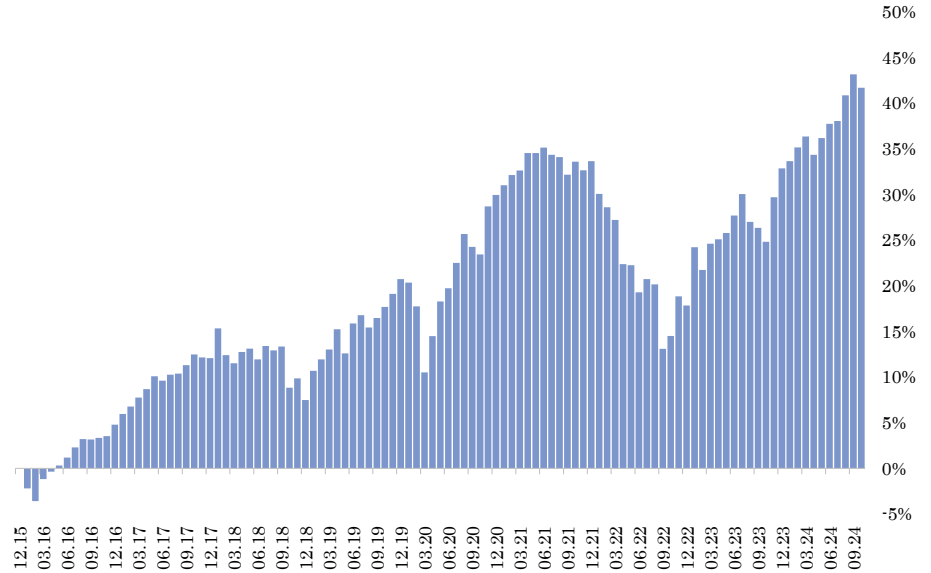
Investment philosophy

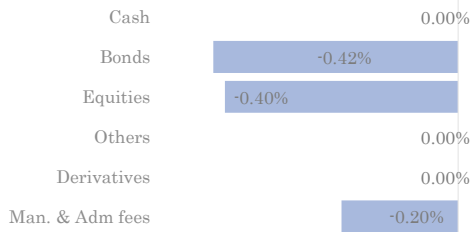

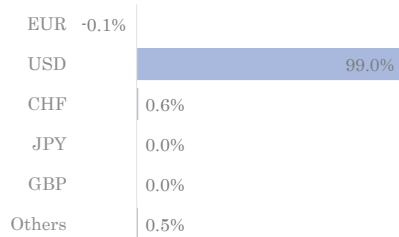
Cumulative net return



Monthly contribution



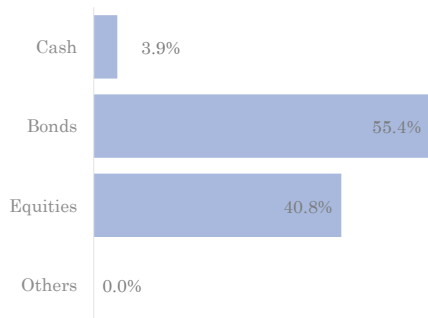
Currency allocation



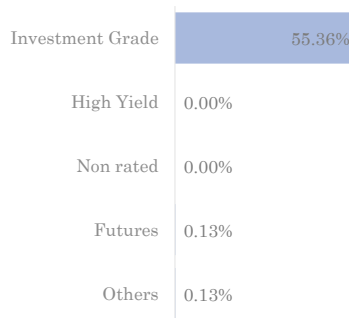

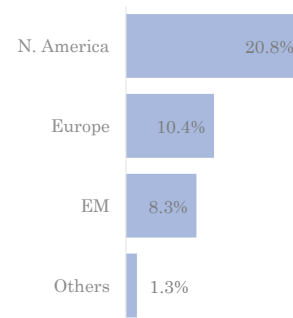
Asset allocation
