

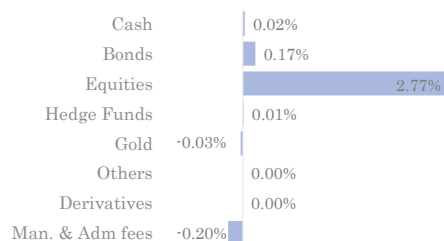
Investment philosophy

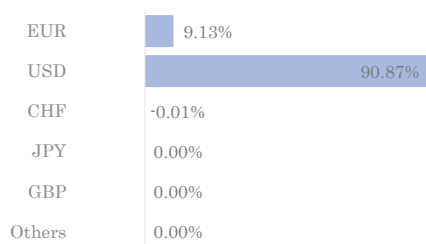

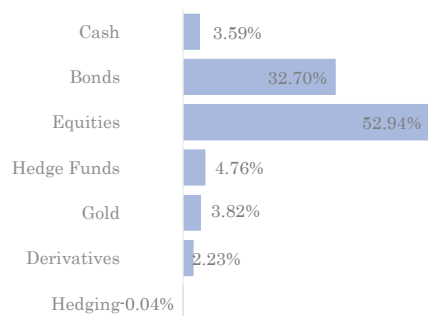
Monthly contribution

Asset allocation



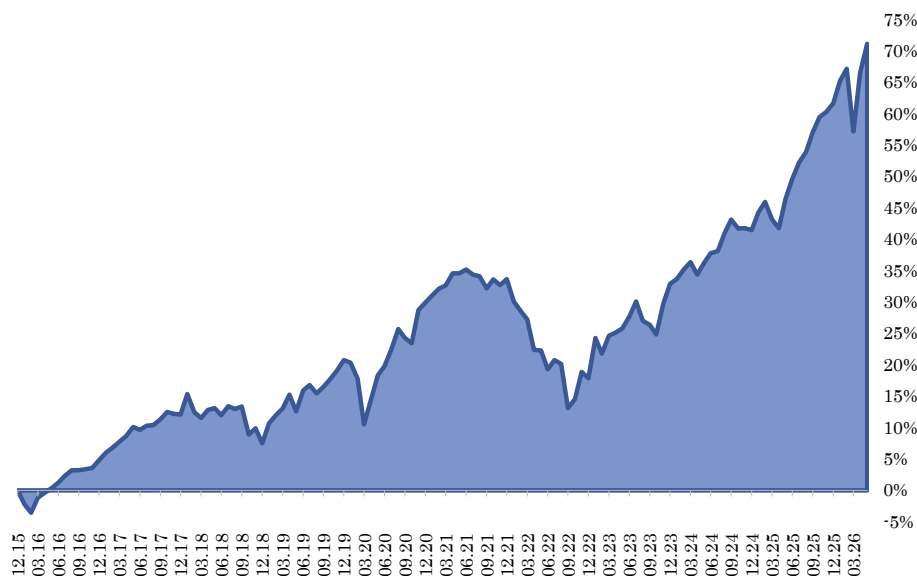

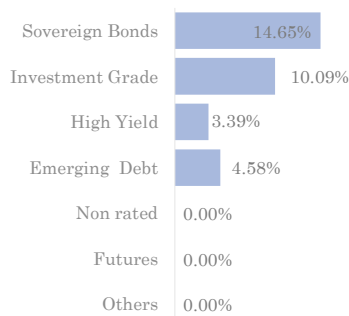
Cumulative net return



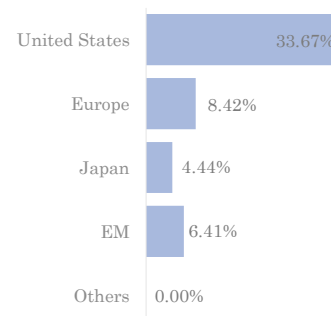
